RESOLUTION NO: 20-09

A RESOLUTION OF THE CITY OF NEWBERRY, FLORIDA, AMENDING RESOLUTION NO: 08-08; AMENDING THE RENTAL FEE AND CLEANING FEE FOR USE OF THE CITY OF NEWBERRY MUNICIPAL BUILDING; ALLOWING FOR DANCING AT THE MUNICIPAL BUILDING AND REPEALING ALL RESOLUTION IN CONFLICT AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS the cost of doing business has increased for the City of Newberry, and such costs should be recouped from consumers using City buildings and services;

NOW THEREFORE, BE IT RESOLVED BY THE PEOPLE OF THE CITY OF NEWBERRY, FLORIDA:

Section 1. The Rules and Regulations for Rental of Municipal Building are amended and shall be provided with municipal building rental as follows:

- 1. INITIAL DEPOSIT REQUIRED IN THE AMOUNT OF ONE HUNDRED (\$100.00) DOLLARS UPON RESERVATION OF THE BUILDING. DEPOSIT MAY BE RETURNED AFTER FINAL CLEAN UP INSPECTION AND RETURN OF THE KEY (Within 72 hours). A TWENTY FOUR (24) HOUR NOTICE OF CANCELLATION IS REQUIRED OR DEPOSIT IS FORFEITED**
- 2. A FIVE HUNDRED (\$500.00) DOLLAR SECURITY DEPOSIT MAY BE IMPOSED ON HIGH IMPACT FUNCTIONS THAT COULD CAUSE DAMAGE TO THE FACILITY**
- 3. THE RENTAL FEE OF \$300.00 PLUS TAX IS DUE UPON PICK-UP AND SIGNING FOR KEY TO BUILDING**
- 4. A FIFTY (\$50.00) DOLLAR NON-REFUNDABLE CLEANING FEE IS REQUIRED, INCLUDING FOR ALL 501-3C OR NON-PROFIT ORGANIZATIONS WISHING TO USE THE FACILITIES**
- 5. A TWENTY FIVE (\$25.00) DOLLAR NON-REFUNDABLE INTERNET CONNECTIVITY FEE IS REQUIRED FOR ACCESS TO THE INTERNET WHILE USING THE FACILITIES**
- 6. NO ALCOHOLIC BEVERAGE**
- 7. NO SMOKING**
- 8. NO PIANOS, OR HEAVY EQUIPMENT OF ANY KIND ALLOWED ON FLOORS**
- 9. NO ROLLER SKATES OF ANY KIND.**

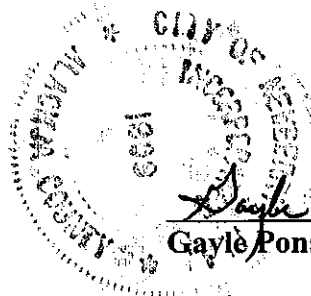
10. DO NOT DRAG OR SLAM TABLES OR CHAIRS ON THE FLOOR.
11. TABLES AND CHAIRS ARE NOT TO BE REMOVED FROM THE BUILDING.
12. DO NOT USE TAPE OF ANY KIND ON WALLS, CEILING, OR FLOOR.
13. KITCHEN, BATHROOM, AND FLOORS MUST BE CLEAN AND ALL TRASH MUST BE PICKED UP, BAGGED, AND DISPOSED OF IN PROPER OUTDOOR TRASH CONTAINERS BEFORE LEAVING IN ORDER TO RECEIVE DEPOSIT
14. WATER HEATERS MUST BE UNPLUGGED, ALL LIGHTS, HEATERS, FANS, AND AIR CONDITIONERS TURNED OFF
15. CHURCH ACTIVITIES FOLLOW THE SAME GUIDELINES AND FEES
16. A CHECKLIST WILL BE PROVIDED
18. A LIABILITY WAIVER FORM MUST BE SIGNED (Attachment A)


Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.


Section 3. This ordinance shall become effective upon passage on second and final reading.
