RESOLUTION NO: 19-11

A RESOLUTION OF THE CITY OF NEWBERRY, FLORIDA, AMENDING RESOLUTION 20-09; AMENDING THE RENTAL FEE FOR USE OF THE CITY OF NEWBERRY MUNICIPAL BUILDING; ADDING A SECOND DAY RENTAL FEE FOR USE OF THE CITY OF NEWBERRY MUNICIPAL BUILDING; REPEALING ALL RESOLUTIONS IN CONFLICT AND ESTABLISHING AN EFFECTIVE DATE

**WHEREAS** the costs and expenses associated with the rented use of the City of Newberry Municipal Building has increased; and

**WHEREAS** said increase in costs and expenses should be included in the rental fee for the private use of the City of Newberry Municipal Building; and

NOW THEREFORE, BE IT RESOLVED BY THE PEOPLE OF THE CITY OF NEWBERRY, FLORIDA:

**Section 1.** The Rules and Regulations for Rental of the City of Newberry Municipal Building (hereinafter "the Municipal Building") are amended as follows:


1. A security deposit in the amount of One Hundred Dollars (\$100.00) is required upon reservation of the Municipal Building. Said deposit may be returned within 72 hours after final inspection and return of the key. Notice of cancellation is required at least 24 hours prior to reservation date or deposit is forfeited.
2. An additional security deposit in the amount of Five Hundred Dollars (\$500.00) may be imposed on high impact functions that could cause damage to the facility.
3. The rental fee for a single day reservation is Three Hundred and Fifty Dollars (\$350.00) plus tax.
4. An additional day rental fee for the immediate day(s) prior to or thereafter the reservation date is One Hundred and Seventy Five Dollars (\$175.00) plus tax, per day. If the renter enters and occupies the Municipal Building on any day not previously reserved, the renter will be charged the additional day rental fee.
5. A rental fee and security deposit shall be waived for all city-related organizations groups, committees, agencies, and bodies.
6. A cleaning fee of Fifty Dollars (\$50.00) may be imposed, at the sole discretion of the City, upon any renter of the Municipal Building. Said cleaning fee is non-refundable.
7. An internet connectivity fee in the amount of Twenty Five Dollars (\$25.00) per day is required to access to the internet while using the Municipal Building. Said fee is non-refundable.
8. Execution of the acknowledgment of the rules and regulations for the rental of the Municipal Building, and the rental fee, internet connectivity fee, cleaning fee, and the security deposit, if applicable, are due upon receipt of the key to the Municipal Building.

**Section 2.** All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

**Section 3.** This ordinance shall become effective upon passage on second and final reading.


